

### Advancing diversity in Cybersecurity



#### -What's new?

As Europe continues to navigate the digital decade, the SHE@CYBER consortium has been making strides to ensure that cybersecurity is not just efficient, but inclusive, and accessible, making organisations resilient.

The summer marked an exciting phase for our project with our consortium engaging in platform pilots and policy impact.

#### - Platform development: Ready for testing

Our development team finalised the technical backbone of the SHE@CYBER interactive learning platform. This milestone included:

- Integration of all learning modules in 5 languages (EN, GR, IT, ES, EL)
- Responsive, accessible design adapted for both desktop and mobile
- User dashboard with progress tracking and interactive learning features
- Gender-inclusive visual design and content sensitivity aligned with European guidelines

Partners began internal testing and debugging to ensure full functionality before the platform is opened to external SME testers in August.

## - WP5 progressing: SHE@CYBER Toolkit & Train-the-Trainer Framework

While the platform deployment is ongoing, the SHE@CYBER Toolkit and Train-the-Trainer Methodology also advanced significantly during June–July.

Led by Exeo Lab (Italy), the toolkit includes:

- Practical exercises for workplace application
- Real-world case studies on SME cyber incidents
- Gender bias detection in digital security scenarios
- Inclusive training strategies and facilitation guides

All partners contributed to national adaptation and contextualisation, ensuring relevance across different business cultures.

The Train-the-Trainer component will be validated by pilot users and educators, making it ready for broad dissemination in September.



## - Dissemination: Social engagement on the rise

Our digital outreach continues to gain momentum:

- The SHE@CYBER website and LinkedIn page remain live and keep our target groups up to date,
- Partner posts highlight project milestones, national relevance, and training opportunities,

We're not just building tools, we're shaping conversations on inclusive cybersecurity in Europe.






## -Next steps
